[(0:02)] FBI Official: Thank you for calling the FBI. Can I have your name and a good contact number for you, please?

[(0:07)] Plaintiff: Sure. My name is Adam, last name is Bereki, it's spelled B-E-R-E-K-I, and my phone number is 9492416693.

[(0:24)] FBI Official: And your date of birth, Adam?

[(0:26)] Plaintiff: 6/18/79.

[(0:30)] FBI Official: And the zip code you're calling from?

[(0:32)] Plaintiff: 92626.

[(0:36)] FBI Official: And is that common spelling for Adam, A-D-A-M?

[(0:39)] Plaintiff: Correct.

[(0:39)] FBI Official: Okay. Give me just one moment, sir. What is the federal crime that you wish to report today, Adam?

[(1:09)] Plaintiff: Deprivation of federal rights by official government actors in California.

[(1:18)] FBI Official: Okay. And what exactly is going on?

[(1:25)] Plaintiff: In 2017, I went to a civil case in court, in Orange County, and I was accused of performing construction work without a contractor's license. As a result of that trial, the judge fined me \$930,000. Oh, he called the action "Something in law that's called disgorgement". So, after that happened, I went to appeal, and the Appellate court upheld the trial court's ruling. I

petition to the California Supreme Court and the US Supreme Court, and both of those petitions were denied.

Well, let me back up and just say for one second, that I'm a retired cop from Huntington Beach, and I have extensive experience in major fraud and forgery. So I requested the legislative history of this bill and did, what has taken me now about two years to research, what has gone on with this. And what California is essentially doing, is they're conducting these actions in a Civil Court, when what they really are, is really highly penal criminal actions where you're supposed to have all of the height and protections of criminal proceedings.

Just to give you an example. Let's say that you do work as a contractor, and you don't have a license, and you get popped by the state license board, you get a ticket, quote-unquote, "It's a misdemeanor". The maximum fine that they can fine you, is \$5000. The fine in California for comparable offense for, like driving without a license, is \$450. So there's clearly a problem here. I do not have the evidence yet but I'm working on evidence of other people. I know one man who was fined \$917,000, I know another company that was fine, \$22.7 million, although ultimately got reversed. What I'm getting at, is that people have reached out to the legislature to cause change and to have them look at the issues that are going on with this enforcement, but nothing is happening.

What I'm sharing with you, I'm not sure if I've made myself clear enough, or maybe you could share with me things that the FBI does handle so that I can be clear that you're not the agency that I need to be with. Because what I'm sharing with you is that, although the initial part of this began in the Civil context, the actions that were taken by the state actors and the state officials in this case, have nothing to do with the initial civil case, they took criminal action in the case. I'm not reporting the civil case you, I'm reporting the actions on behalf of the state actors that are criminal.

The fact that your attorney gave you bad advice, I mean, you can seek different legal counsel, but that's not going to change the fact that the FBI is not going to be able to assist you, okay?
